Compliance challenges

Ongoing regulatory developments in the financial sector are making the compliance officer's role increasingly complex. Beyond the regular controls to be performed and reported on in accordance with their monitoring plans, compliance officers often have to dedicate considerable time to addressing specific compliance issues or assimilating new regulatory requirements.



Shouldering your compliance load

To make compliance officers' lives easier, Arendt Regulatory & Consulting has created CAROL, an internet-based solution that lets users monitor the compliance of a regulated entity by means of an online control monitoring plan (CMP) suited to its regulatory status. CAROL covers the needs of Luxembourg-based investment fund managers (with or without an additional MiFID license), investment firms and depositary banks, as well as EU investment fund managers managing products in Luxembourg.

CAROL is both a central point of access to regulatory texts and compliance monitoring tool. Users can customise a CMP that permits clear, ongoing compliance risk assessment and

scoring. At the same time, they have access to regulation mapping that is tailored to the regulatory status of their company. Arendt Regulatory & Consulting continuously sorts the inflow of regulations and updates the catalogue of regulatory texts.

By freeing up much of the time compliance officers and staff would otherwise spend on periodic controls, CAROL enables those in charge of compliance to focus on daily business and special projects, while keeping abreast of regulatory changes.



- ▼ Regulatory Mapping Access an up-to-date list maintained by Arendt Regulatory & Consulting of all existing legislation, regulations and circulars for your entity's regulatory status, including direct links to official texts and available translations.
- ✓ Compliance Monitoring Plan See all requirements for your entity, filter by topic, input the compliance measures taken and determine your risk of non-compliance. Define each requirement's level of importance and add specific settings for each periodic control process.
